PROCEEDINGS OF COUNTY COMMISSIONERS MELLETTE COUNTY, SOUTH DAKOTA October 1, 2024

The meeting of the Mellette County Board of Commissioners was called to order by Chairman Krogman in the Commissioner Room in the Mellette County Courthouse at White River, SD on October 1, 2024 at 9:00 am. Commission members present were Casey Krogman, Dan Valburg, and Jr. Brandis; also present was Auditor Jenny Galbraith.

All motions are to be considered unanimous unless otherwise stated.

The pledge of allegiance was recited. A motion was made to approve the agenda with the addition of deputy hours under Treasurer by Valburg, seconded by Brandis.

<u>Executive Session in accordance with SDCL 1-25-1</u>: Shirley Bruning requested executive session to discuss personnel matters. Motion by Valburg, second by Brandis to enter executive session at 9:10 am; at 9:39 am Chairman Krogman declared executive session over

<u>Auditor:</u> Auditor Galbraith updated the Commission on the cybersecurity analysis being performed by DSU Project Boundary Fence and CISA.

<u>Director of Equalization:</u> Haley Gallant joined the meeting and updated the county on attending assessor school in Chamberlain September 16-20. Gallant discussed with the state her reassessment and it was decided best to apply all the reassessment changes in 4 years once she has completed the entire county so that everything is equally increased.

<u>Treasurer:</u> Hilary Nesheim joined the meeting and requested that her deputy hours be increased from 20 hours per week to 32 hours per week in order to retain her employee. Motion by Valburg to increase Treasurer deputy wages to 32 hours per week seconded by Brandis.

<u>2014 Ford Explorer Sealed Bids:</u> It was advertised September 18 & 25, 2024; one sealed bid was received from Mike Rasmusson for \$1250. Motion by Valburg to accept the bid from Rasmusson, seconded by Brandis.

Road & Bridge: A petition was received at the September 3, 2024 meeting from Andrew & Jessica Fridley and Trinity Ranch to vacate a section line road. Notice of Public Hearing was advertised September 18 & 25, 2024, no public appeared. Motion by Valburg to approve Resolution 2-2024 to vacate the section line road, seconded by Brandis:

WHEREAS, a petition was filed with Mellette County ad a public hearing occurred pursuant to Chapter SDCL 31-3;

WHEREAS, the subject road is not improved or currently traveled or utilized, and the public interests are not adversely impacted and are better served by vacating the subject road;

NOW, THEREFORE IT BE RESOLVED by the Mellette County Commission of Mellette County that the section line beginning in the east common corner of the SE1/4SE1/4 of Section 17 and the NE1/4NE1/4 of Section 20 ending at the west common corner of the SE1/4SE1/4 of Section 17 and the NE1/4 NE1/4 of Section 20, Township 41 North, Range 28 West of the 6th P.M. Mellette County, South Dakota is now VACATED.
