PROCEEDINGS OF COUNTY COMMISSIONERS MELLETTE COUNTY, SOUTH DAKOTA September 2, 2025

The meeting of the Mellette County Board of Commissioners was called to order by Chairman Brown in the Commissioner Room in the Mellette County Courthouse at White River, SD on September 2, 2025 at 9:03 am. Commission members present were Vernon Brown, Wesley Schmidt, and Jr. Brandis; also present was Auditor Jenny Galbraith.

Visitors: Leroy Greaves

All motions are to be considered unanimous unless otherwise stated.

The pledge of allegiance was recited.

A motion was made to approve the agenda by Schmidt.

Provisional Budget Hearing was held; no public appeared regarding the proposed budget. Commission will meet on September 22, 2025 for final approval.

Road & Bridge: Highway Superintendent Tre Iyotte provided the Commission with a written update on work that has been completed over the last month and work that they are planning on for the next month. Leroy Greaves joined the meeting to request from the Commission to cross a county road in order to get water to his pasture located 9 miles north of Cedar Butte on County Road 6. There was discussion of his intentions on how and exactly where the water line would cross. Motion was made by Schmidt to allow him to cross the road at the requested location as long as the water line was bored under the road instead of digging a trench, second by Brandis. Greaves will work with Tre on this project and keep him updated.

<u>Auditor:</u> Auditor Galbraith requested travel to attend the election workshop in Pierre on October 29-30, 2025. Motion by Schmidt to allow travel with reimbursement for mileage, second by Brandis.

Sheriff: Sheriff Gildemaster requested travel to Watertown for the Sheriff's conference September 29, 2025 – October 1, 2025 to include hotel stay and mileage. Motion by Schmidt to approve travel, second by Brandis.

Executive Session in accordance with SDCL 1-25-1: Brown requested executive session to discuss personnel matters. Motion by Schmidt to enter executive session at 9:57 am, second by Brandis. At 11:00 am Chairman Brown declared executive session over.

<u>Unfinished Business:</u> Commission discussed updates to the employee handbook. The update of the leave accrual policy Section 402A and 404A will be changed from 8 hours per month to 4 hours per pay period since payroll was switched to bi-weekly. Motion by Schmidt to make this change effective September 1, 2025, second by Brandis.

<u>New Business:</u> Auditor Galbraith discussed the need for some changes to the courtroom and Clerk of Courts office, painting and carpet. Will discuss with the maintenance person and see if he is willing and will get some prices together for the October meeting.
