## PROCEEDINGS OF COUNTY COMMISSIONERS MELLETTE COUNTY, SOUTH DAKOTA October 7, 2025

The meeting of the Mellette County Board of Commissioners was called to order by Chairman Brown in the Commissioner Room in the Mellette County Courthouse at White River, SD on October 7, 2025 at 9:00 am. Commission members present were Vernon Brown and Wesley Schmidt; also present was Auditor Jenny Galbraith.

Visitors: Brandi Hodges

All motions are to be considered unanimous unless otherwise stated.

The pledge of allegiance was recited.

A motion was made to approve the agenda by Schmidt, second by Brown.

Road & Bridge: Highway Superintendent Tre Iyotte and highway maintenance worker Ray Driesbaugh joined the meeting. Iyotte provided the Commission with a written update on work that has been completed over the last month and work that they are planning for next month. Commission completed a six-month evaluation on Ray Driesbaugh. Motion by Schmidt to increase Driesbaugh's wages from \$18.50 per hour to \$21.50 per hour. Iyotte requested that Driesbaugh attend SDLTAP Local Roads conference in Sioux Falls on October 20 - 22, 2025; motion by Schmidt to approve the travel, second by Brown. Commission revisited the MOU from Rosebud Sioux Tribe for the purchase of gravel from the Two Kettle gravel pit and decided to hold off on purchasing until spring 2026.

<u>Register of Deeds:</u> ROD Stanley Krogman Sr. requested to attend driver's license training in Sious Falls on September 10-11, 2025; motion by Schmidt to approve travel, second by Brown.

<u>Unfinished Business:</u> Commission discussed positions of Emergency Manager, E-911 Address Coordinator, and Ambulance Coordinator.

Executive Session in accordance with SDCL 1-25-2(1) re. personnel: Brown requested executive session to discuss personnel matters. Motion by Schmidt to enter executive session at 11:43 am, second by Brown. At 11:59 am Chairman Brown declared executive session over.

Motion by Schmidt to send a letter to current Emergency Manager and E-911 Coordinator officially terminating employment and requesting all county property be returned.

New Business: Brent Kolstad with SD OEM joined the meeting to discuss the Emergency Management position with the Commission. Kolstad provided information on requirements and state laws of the position.
