PROCEEDINGS OF COUNTY COMMISSIONERS MELLETTE COUNTY, SOUTH DAKOTA DECEMBER 2, 2025

The meeting of the Mellette County Board of Commissioners was called to order by Chairman Brown in the Commissioner Room in the Mellette County Courthouse at White River, SD on Tuesday, December 2, 2025 at 9:07 am. Commission members present were Vernon Brown, Jr. Brandis, and Wesley Schmidt; also present was Auditor Jenny Galbraith.

Visitors: None present.

All motions are to be considered unanimous unless otherwise stated.

The pledge of allegiance was recited.

TWOTREES TECHNOLOGIES

A motion was made to approve the agenda by Brandis, second by Schmidt.

<u>Road & Bridge:</u> Highway Superintendent Tre Iyotte joined the meeting. Iyotte provided the Commission with a written update on work that has been completed over the last month and work that they are planning for next month.

<u>Auditor</u>: Auditor Galbraith informed the Commission that there will need to be a budget supplement hearing held in December, it was decided that it will be held on December 29, 2025. At that time there will also need to be operating transfer out of funds to Fire, Emergency Management, and E911. Galbraith also requested that DOE Haley Gallant be paid for covering the Auditor's office while she was out on medical leave. After discussion Schmidt made a motion to pay Gallant an additional \$200 for the month of November, second by Brandis.

<u>Unfinished Business:</u> Commission discussed positions of Emergency Manager, Ambulance Coordinator, and Coroner. Commission discussed contacting O'Brien to discuss position of Coroner and to get county property returned for E-911 and Emergency Manager; Schmidt will contact O'Brien to discuss. Commission discussed annual personnel bonuses. After much discussion it was decided that elected officials will not receive any bonus and hired personnel and appointed supervisors will receive \$50 per month for every month worked in 2025 with the exception of Roy Warner who will receive \$200.00; motion by Schmidt, second by Brandis.

<u>New Business:</u> Commission reviewed the Charles Mix prisoner housing contract that was received. Motion by Schmidt to sign the agreement, second by Brandis.

<u>Approval Of Proceedings</u>: Motion by Schmidt to approve the proceedings of November 4, 2025 seconded by Brandis.
